It has been tabled until next month after we have our budget in place on whether we will send an additional \$1000, or an additional \$1500

- Motion made by Jesse F. and seconded by Scott B. to take back our current policies and procedures to our home groups for review of and possible revisions be made to help determine and clarify the Alternate RCM/RCM service position's term length in order to determine if policies and procedures should make changes to what is currently in place. - Thomas R. made a motion to reimburse him \$46.65 for expenses for his trip to the regional meeting. Motion was 2nd by Johnny D and denied due to having no receipts to turn in except for gas receipt. This was an issue last year and reimbursement was made since it was the first time attending and there was confusion. The motion was amended to reimburse \$26.65 for the receipts turned in since it was made aware that receipts were needed for any reimbursements. See attached motion form.

- Johnny D. made a motion to give a check made out to Copy Cat Printing in the amount of \$142.86 to Sheila H. in order to have new meeting schedules printed. Motion was 2nd by Thomas R. and carried.
- Kelly L made a motion for \$1200.00 to replenish and stock up on literature supplies and it was carried.
- Thomas R. is nominated for RCM. No questions were brought back for Thomas to answer. Have your home group's voting response for Thomas at the February area meeting.
- Janine W. is nominated for Alternate RCM. Below are the home groups that had questions, what the questions were, and what Janine's responses were. Have your home group's voting response for Janine at the February area meeting.
 - Omega- Are you able to fulfill the Alt. RCM position and how is this different from when you stepped down as Area Treasurer position?

Response: She wasn't present at the area meeting when she was voted in. She should have had to be present to be voted in, and said she did not inform anyone of her decision to withdraw her nomination prior to her being voting in was made. She states that she has completed all service positions throughout the term length, but was not required to after her term ended until someone else was voted in. She states that she does not understand why everyone thinks she does not fulfill her service commitments. I only recently stepped down from Regional H&I Chair due to issues with traveling. She states she may have a transportation issue occasionally as she has to transport her son to and from work, but that she doesn't foresee any other issues.

• Omega – Are you going to be able to travel to regional commitments when the RCM is not available to go and once you are the RCM?

Response: I may not be able to make it to Regional Meetings because I have to drive my son back and forth to work, which would prevent me from being able to attend the meetings.

Omega question: Are there any other options to help get your son to and from work if you had to attend a meeting in replacement of the RCM, such as uber, or other public transportation options?

Response: No there are no other options, I have to take him. There are no Uber driver's in the area of Salisbury where I live.

• A New Way- Do you plan to fulfill and are you willing to fulfill the 2 (or 4) year commitment if policies and procedures extend the length to 4 year?
